1. OFFER AND ELIGIBILITY

- b. By participating in the Promotion, you agree to be bound by these Terms
- c. The Promotion is available at Numurkah Aquatic and Fitness Centre, Warragul Leisure Centre, South Gippsland SPLASH, Ashburton Pool and Recreation Centre, Boroondara Sports Complex, Hawthorn Aquatic and Leisure Centre, Horsham Aquatic Centre, North Melbourne Recreation Centre, Benalla Aquatic Centre, Peter Krenz Leisure Centre, Bass Coast Aquatic and Leisure Centre, Phillip Island Leisure Centre, RecWest Footscray and Macleod Recreation and Fitness Centre (Participating Centres) between the dates of 1 October to 29 October 2024 (Promotion Period). The promotion is available at Brunswick Baths, Coburg Leisure Centre, Oak Park Sports and Aquatic Centre (Participating Centres) between 3 October to 29 October 2024 (Promotion Period).

 - a. South Gippsland SPLASH, Phillip Island Leisure Centre, Coburg Leisure Centre, Brunswick Baths, Oak Park Sports and Aquatic Centre, Bass Coast Aquatic and Leisure Centre, Peter Krenz Leisure Centre, Numurkah Aquatic and Fitness Centre, and Benalla Aquatic Centre.
 - 3. No lock in
 - a. Warragul Leisure Centre, Macleod Recreation and Fitness Centre, Horsham Aquatic Centre, North Melbourne Recreation Centre, Ashburton Pool and Recreation Centre, Boroondara Sports Complex and Hawthorn Aquatic and Leisure Centre.
 - ii. To qualify, you must be 18+ years old and a new member.
 - iii. A photo ID is required for entry.
- e. The Promotion is only available at Participating Centres
- f. All other applicable fees and charges in respect of the membership will be payable in accordance with the applicable membership terms. Your membership will otherwise be governed by such membership terms.
